2. Description of the product

- **Intended use:** Decorative items for summer occasions, indoor and outdoor decoration as well as floral arrangements.
- **Material composition:**
 - **Materials:** wood, plastic (e.g. PE, PP), ceramic, glass, metal, textiles, paper or natural materials (e.g. shells, rattan).
 - **Surfaces:** Colored, varnished, coated or decorated (e.g. glitter, patterns, prints).
 - **Additives:** paints, adhesives, cords, ribbons or textile applications.

3. Possible dangers

- **Fire hazard:** Natural materials, textiles, paper and plastic parts are highly flammable.
- **Risk of cutting or stabbing:** Glass, metal or broken ceramic elements can cause injuries.
- **Choking hazard:** Small decorative elements, ribbons or appliqués can be swallowed by children or pets.
- **Mechanical stress:** Heavier decorations can fall and cause injuries.
- **Chemical exposure:** Paints, varnishes or adhesives can cause irritation if they come into direct contact with the skin.

4. Safety instructions

4.1 General safety instructions

- **Keep away from children and pets, especially small parts or sharp edges.**
- **Keep away from open flames, heat sources and sources of ignition.**
- **If you have known allergies, avoid direct skin contact with treated surfaces.**

4.2 Notes on use

1. Use summer decorations for decorative purposes only.
2. Handle fragile materials carefully and place them safely on stable surfaces.
3. When using outdoors, make sure it is weatherproof.
4. Check regularly for loose or damaged parts to avoid injury.
5. Avoid exposure to moisture unless the product is suitable for outdoor use.

4.3 Storage instructions

- Store in a dry, cool place protected from light to minimize material aging and discoloration.
- Pack fragile items shockproof and store them safely.
- Protect products from moisture to prevent mold growth.

5. First aid measures

- **In case of cuts or puncture wounds:** Clean and disinfect the wound and seek medical attention if necessary.
- **If skin irritation occurs due to paints or coatings:** Clean thoroughly with soap and water.
- **If eye irritation occurs due to dust or particles:** Rinse immediately with clean water and seek medical advice.
- **If small parts are swallowed:** Do not give food or drink and seek medical attention immediately.
- **If dust is inhaled:** ensure fresh air supply and seek medical advice if symptoms persist.

6. Firefighting measures

- **Suitable extinguishing media:** CO₂, foam, powder, water.
- **Special measures:** Wear respiratory protection as burning paints, varnishes or coatings can produce toxic fumes.

7. Storage and transport

- **Storage:**
 - Store in a dry, dust-free place and protected from light.
 - Stack or pack products safely to avoid damage.
- **Transport:**
 - Transport fragile or sensitive decorative items in a shock-protected manner.
 - Protect products from moisture.

8. Disposal instructions

- **Material-dependent disposal:**
 - Wood, paper and natural materials: composting or residual waste.
 - Plastic and metal parts: Recycling according to local regulations.
 - Coated or painted articles: residual waste.
- **Packaging materials:** Recycling according to local regulations.
